- Two case studies from last year's call were presented at the 2018 World Government Summit in Dubai.
- The World Government Summit brings together over 130 countries and 4 000 people to discuss innovative ways to solve the challenges facing humanity
- Innovations from last year were focussed on the following areas: identity, system approach and enablers, and inclusiveness and vulnerable populations.
