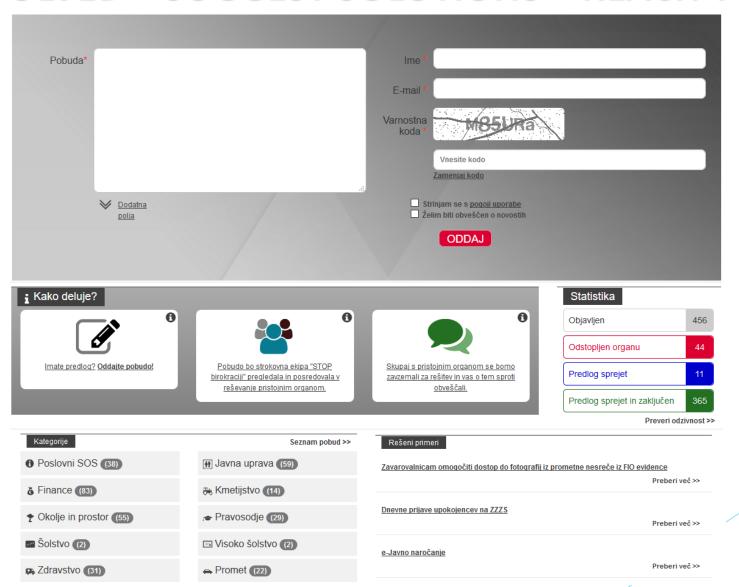

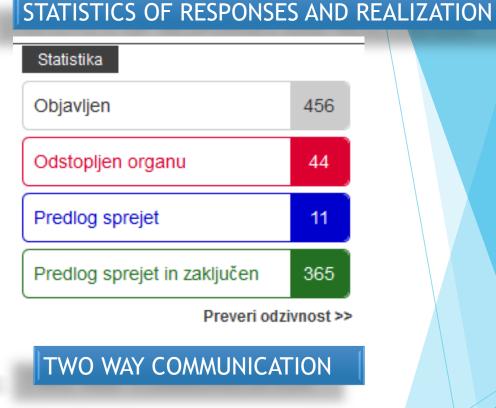

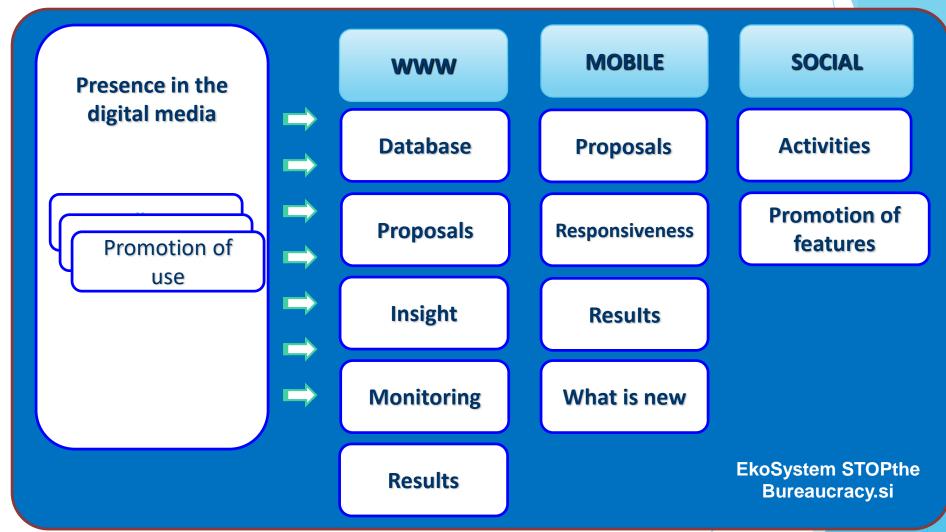

- Separation of entities entities for the realization and permanent entity (entities that do not have a deadline for implementation).
- Searching entities according to general criteria, such as: title, description, an area involved ministries, the reporting period, the status of realization, etc.
- For each objective and its tasks, list of all reporting (history overview) on the status of implementation is available.
- In the public part of the application there is display of statistics for the selected module. Statistics are displayed in an interactive way (with infographics).



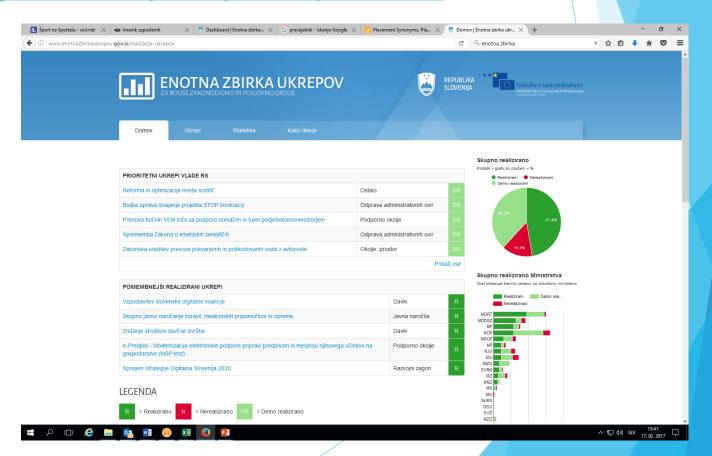

Main page for EZU (prioritization, measures, statuses, statistics)

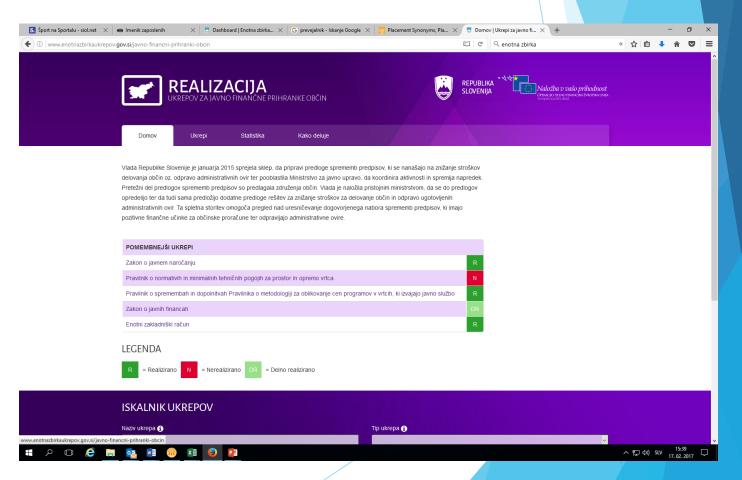
