We would like to complete the "Born in Belgium Professionals" questionnaire with you, using the Born in Belgium Pro platform. This questionnaire is intended to better support pregnant women in terms of psychosocial well-being and was approved by the UZ Brussel Ethics Committee on 18 December 2019 (scientific research B.U.N. 143201941861).

Do you agree to participate in the "Born in Belgium Professionals" project? If so, your professional caregiver will ask a few questions about your current life situation and well-being. Depending on your answers, you will be offered a care pathway adapted to your needs. We need your consent to:

- answer the above-mentioned questionnaire in the presence of your professional caregiver;
- be offered a care pathway adapted to your needs and based on your replies to the questions;
- save your answers to this questionnaire on a secure electronic platform which will only be visible to authorised professional caregivers who are bound by professional (medical) secrecy without obligation to report. This is in order to support you as efficiently as possible.
- Your anonymised data will be used for statistical purposes and to improve the functioning of the platform.

At any time, you are entitled to terminate your participation in the project without having to give a reason. There will be no impact on the continuity of care, it will still be assured by your professional caregiver.

If you agree to take part in the scientific research as well, your data will be anonymized. You can stop your participation in the study at any time.

All your consents and your approval will be registered in the Born in Belgium Pro platform, in the presence of your professional caregiver.

All employees of the Born in Belgium Pro project care a lot for your privacy and respect all applicable laws when processing your personal data. The privacy statement which is available on the website, explains how this works.

We respect your rights and your privacy

Your caregiver **only** collects the information needed to detect (possible) care needs in pregnant women and ensure a good referral:

- Your **contact details**
- **Information** about your pregnancy, your personal **situation and well-being**
- The names of your **healthcare providers**

These data are **pseudonymised** (i.e. your name is not linked to your answers) and stored on a **secure database** with respect for privacy and GDPR legislation, until the end of the care.

Your other caregivers, bound by (medical) **professional secrecy**, can consult this information. Non-medical care providers will **not** have access to your medical information.

At any time, you can access your personal information, correct or complete it and have it deleted. You can view the answers you gave and ask to be given a print out.
