"The Small Business Friendly Approvals Program facilitated by the Small Business Development Corporation (SBDC) provided a valuable framework for the City to examine how we support local businesses, where we can reduce ted tape and how we can orient our approvals processes to be solution and customer focused.

Factors that contributed to success of this initiative include having staff from multiple business units in a week-long intensive workshop where issues were identified and resolved in session. The external facilitators provided by SBDC were extremely professional, knowledgeable, and able to dig into sticking points and push for innovative solutions, as well as provide a perspective on how other Local Governments had responded to similar challenges. Staff involved in the process also reported that hearing directly from local businesses was significant and inspired a reorientation of what 'business as usual' looks like at the City.

Another factor in the success of this program is the way in which City staff leant into the program and made the cultural shifts required to ensure administrative reforms were effective.
