**ABOUT
REPLICATION OF SANPIISAN PUBLIC SERVICE INNOVATION**

Today, Thursday, the seventh of July, two thousand two and twenty two (7-7 2022), the undersigned below:

1. Name : Badai Ismoyo, SKM.MM
Position : Head of the Kudus District Health Service

In this case, he is acting in his position for and on behalf of the Kudus District Health Service which is located at Jalan Diponegoro No. 15 Kudus, hereinafter referred to as • FIRST PARTY".

2. Name : Dr. Abdul Hakam, Sp.PD FINASIM
Position : Head of the Semarang City Health Service

In this case, he acts in his position for and on behalf of the Semarang City Health Service, hereinafter referred to as the "SECOND PARTY".

With the issuance of this letter, the FIRST PARTY and the SECOND PARTY have agreed to be bound to make and implement a Cooperation Agreement regarding SANPIISAN public innovation replication activities owned by the 'SECOND PARTY' with the following provisions:

Article 1

THE FIRST PARTY as the one who replicates the SANPIISAN innovation (Love the mother and child of Semarang City) will follow the rules set by the SECOND PARTY

Article 2

THE FIRST PARTY appointed the SECOND PARTY as the location to replicate the SANPIISAN innovation owned by the SECOND PARTY, the principle of innovation carried out by the FIRST PARTY was to complement and develop the innovation that the FIRST PARTY already had, namely SIBULAN (Saveand Children's First Steps Towards Hope) to have an optimal impact on saving mothers and babies in the District

Article 3

- (1) The purpose of this Cooperation Agreement is as a basis for the joint implementation of the PARTIES to collaborate in replicating the SANPIISAN innovation owned by the SECOND PARTY
- (2) The aim of this Cooperation Agreement is to provide the best possible health services to the community in Kudus Regency, especially in saving mothers and babies which has an impact on reducing maternal and infant mortality rates and stunting.

Article 4

The agreed scope of replication includes:

1. Know what SANPIISAN innovation is
2. Concepts and techniques for implementing SANPIISAN innovation
3. The results of SANPIISAN innovation
4. Monitoring and evaluation of SANPIISAN

Article 5

FIRST PARTY shall be entitled to :

- a. Comply with the regulations set by the SECOND PARTY
- b. Obtain complete information about SANPIISAN innovations from the SECOND PARTY;
- c. Learn and see firsthand SANPIISAN innovation from the SECOND PARTY;
- d. Consumption both directly and indirectly

THE SECOND PARTY is obligated:

- a. Providing clear and detailed information about SANPIISAN innovations
THE FIRST PARTY;
- b. Receive consultation from the FIRST PARTY;

If during the implementation of this Cooperation Agreement the PARTIES feel the need to make changes, then these changes can only be made with the agreement of the PARTIES as stated in the Addendum to the Agreement which is an inseparable part of this Cooperation Agreement.

Article 6

This Cooperation Agreement is drawn up and signed by THE PARTIES, on the day, date, month and year as stated at the beginning of the Cooperation Agreement and made in 2 (two) copies, each with sufficient stamp duty and having the same legal force for the PARTIES.
